### **EXIT REPORT**

## By Francisco G. Ladaga TA for Agricultural Extension and Mainstreaming UDP Schemes April to June 2007

#### **Rationale**

EO 606, which was recently promulgated to promote sustainable upland development (SUD) countrywide, is both a milestone and challenge to the UDP and the LMP as originators of the national policy. The order's successful implementation is a concern of the UDP as it phases out this year or when the program will have no direct input in the field.

The executive order with its national in scope has some added dimensions from the UDP experience in Southern Mindanao. It therefore necessitates orientation for deeper understanding among the key implementers particularly at the MLGUs of the UDP-covered areas to serve as national pilot. Since the EO's successful implementation needs budgetary support, the orientation included the call for indicative SUD budget allocations for 2008 in each UDP-covered MLGU.

This TA engagement was designed to strengthen the teamwork among the MA, ME, MENRO MPDC under the framework of EO 606 including the provision of indicative budgetary allocations for CY 2008 with 2006 and 2007 as base years when the SUD schemes were provided with budgetary allocations. It also advised the MLGUs on the role of the LMP in the implementation of EO 606.

This report presents the inputs of this TA pursuant to the terms of reference, as follows:

- 1. Analysis of the provisions and the draft guidelines of EO 606
- 2. Designing the methodology for the orientation and budgeting workshop the implementation of EO 606
- 3. Conduct of the workshop with key MLGU Officers
- 4. Other inputs

## **Accomplishments**

## Analysis of the provisions and draft guidelines of EO 606

EO 606 and its draft guidelines were analyzed prior to designing the methodology for the orientation and budgeting workshop. The order and its guidelines outlined the SUD implementation under the convergence framework involving the MENRO, MA, DAR officer, ME, MPDC at the MLGU level. The order pointed to the MENRO as the central figure in the implementation since some uplands are under the public domain, however, there was no provision contrary to the existing working mechanism among the key MLGU officers.

The convergence framework called for the revisiting the agency mandates and roles for the effective implementation of EO 606. It has been proven effective to attain holistic development particularly in the upland conditions.

### Designing the methodology for the orientation and budgeting workshops

Based on the analysis of EO 606 and the circumstances in the field, the following procedures were used in the orientation and budgeting workshops:

- 1. Conduct of the orientation and budgeting workshops in each MLGU involving the MA, MENRO, ME, MPDC and Budget Officer (BO).
- 2. Scheduling the activity to cover more than one MLGU each day

- 3. Round table discussion and workshop
  - a. Discussion for clarifications on the provisions and implementing guidelines of EO 606. Clarificatory questions and answers were adequately conducted.
  - b. Review of the development schemes in the SUD model outlining their benefits and achievements to heighten their interest to pursue replication of SUD schemes. The benefits and achievements from the schemes are outlined below.

- c. Presentation of the approved SUD budget for 2006 and 2007 by MLGU Officers, MPDC/Budget Officer/MA/ME/MENRO as basis for 2008 budgetary allocation.
- d. Providing the framework for integrated budgeting the SUD schemes under EO 606 to enhance complementation.
- e. Workshop for the provision of indicative budget allocations for SUD in 2008 thru the collective efforts of the MPDC, BO, MA, ME, MENRO.

## **Conduct of the workshops**

The orientation and budgeting workshops were conducted using the procedures outlined above. They were conducted in each municipality within April and May 2007 with the schedules below.

**Indicative budgetary allocations** – Pursuant to the implementation of EO 606, the MLGU Officers provided indicative budgetary allocations for Calendar Year 2008 covering the major SUD schemes, the LUB-BDP. Upland Agricultural Extension Delivery Scheme/DFS, BFPMS and the LBRRM. The MLGU Officers (Budget Officer, MPDC, MA, MENRO, and ME) jointly estimated the budgetary allocations and affixed their signatures in the workshop outputs presented at the appendices of this report. They were hopeful for the approval of the indicative budgetary allocations by the new sets of MLGU officials. They further suggested endorsement notes from the UDP Co-Directors to the MLGU executives.

The indicative budgetary allocations were mostly from the AIP with some augmentation from the general fund. Almost all MLGU budget allocations showed huge incremental increases while few had meager or no increases at all due to previous commitment like loan repayments.

The budgetary allocations as summarized from the workshop outputs are presented in the succeeding pages.

- This TA provided advisory services during UDP meetings with the Management Committee and served as lecturer in RRDEN XI and RRDEN XII workshops on May 2 and June 14, 2007.
- 2. This TA expounded the advantages of the LMP and advised the MLGU officers to link with the LMP in its coordinating and fund-sourcing role for the MLGUs; also informed them of the forthcoming operation of the Mayors' Development center, a beneficial structure for the MLGUs.

- 2. Provide copies of the budgetary allocations to respective MLGUs executives with a cover note to push for its approval.
